**Movement for Black Lives:** Joel had reported last month on a coalition of social justice organizations called Movement for Black Lives. He had read a summary of their goals and positions on issues but time was short and the item had to be postponed to the October meeting. Joel read a letter from DFA's Jim Dean on behalf of the Movement for Black Lives, in which Dean made an appeal for individuals to make financial contributions to the organization. Joel will send the information he has to the steering committee, including the demands being made and the groups and individuals that have endorsed, and the steering committee will read through the material and make a recommendation to the club members at the next meeting.

**Good government:** Mary reported that SB 1107, which overturns the ban on public financing of elections, was signed into law by Governor Brown. **Social justice:** Joel reported on an on-line class he is taking on slavery; there are currently 46 million slaves in the world, many in Southeast Asia or Africa. If these people formed a country, they would be about the size of California in population. However, they would be third in the world in terms of their greenhouse gas emissions. Slaves are exploited in activities like mining and shrimp farming, which cause deforestation and other environmental problems.

John pointed out that drug companies sell products all over the world at much lower rates than we pay in the United States and lower than VA rates.
